From 91 N and S: Take the Trumbull Street exit #32 B and go straight up Trumbull Street. Take first right onto Windsor Street. *(Continued below)*

From I- 84 West: Take the Main Street exit #50, go left at the light, bear right going through the Main Street light intersection. *(Continued below)*

From I-84 East: Take the Main Street exit #50, at light go right onto Market Street, then first left onto Trumbull Street. *(Continued below)*

Take first right onto Windsor Street. Follow for 1.5 miles to #555, a gray building on the left. Visitor parking is on the right, across the street from the building. Please see receptionist upon entering.

Bridgeport City Hall

From I-95: Take exit 27 Lafayette Blvd. Take Lafayette to John St. Turn right, go to 2nd light Main St. Chase Manhattan Bank and the City Hall Annex are on the corner. *(Continued below)*

From Rt 25: Take exit 2, at light, stay straight cross Fairfield Ave & bear left. Go to John St. turn left. Bank and City Hall Annex are 2 lights up. *(Continued below)*

*Go to the fourth floor in the parking garage and walk across the parking lot.
There is a charge for parking at the Bridgeport location.*
